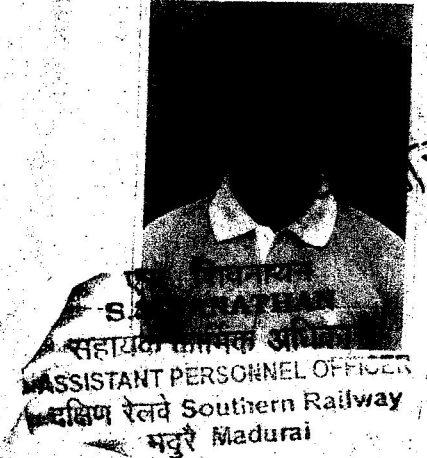

The under mentioned candidate who has been selected for appointment in Group 'C' services as Technician Gr.III/C&W in PB Rs.5200-20200+GP Rs. 1900 by RRB/Chennai/TVC against Direct recruitment quota is appointed as Apprentice Technician Gr.III/C&W on a stipend of Rs.5830+GP.Rs.1900 P.M. plus other allowances as admissible to such apprentices as per rules in force from time to time on the terms and conditions stipulated in this office offer of appointment under reference issued to them and was accepted by him. He is directed for 6 months training under SSE/C&W/MDU as per the training programme enclosed.

He has been medically examined and found fit in the requisite medical classification, vide Sr.DMO/RH/MDU Medical Certificate number mentioned below. Appointment as Apprentice Technician /Gr.III/C&W will take effect from the date of commencement of the training.

His appointment is subject to the following conditions:

- 1) He should undergo the prescribed period of training and pass the same successfully. If he does not complete the same successfully, he is eligible for second chance without payment of stipend if considered necessary by the Administration.
- 2) If he fails in the initial training and also in the second chance, he will be discharged.
- 3) He will be on probation for a period of 2 years from the date of his absorption against working post after successful completion of apprenticeship training and his confirmation will be subject to the satisfactory performance during the period of probation.

- 4) It must be clearly understood that his employment under Government is temporary and his services will be terminated at any time without notice, if such termination is due to the expiry of the officiating vacancy in which he may be appointed or due to mental or physical incapacity or due to removal or dismissal as a disciplinary measure after compliance with the provision of clause (2) of Article 311 of the constitution of India. Otherwise his services will be terminated at any time after giving 14 days notice by either side without any reasons being assigned. The appointing authority however, reserves the right of terminating the services, forthwith or before the expiry of the stipulated period of notice by making payment to him an amount equivalent to the pay and allowance for the period of notice or the unexpired portion thereof. He should not resign or quit his employment except with the previous consent in writing of the Head of the Department or office in which he is employed.
- 5) He will be governed by new restricted defined contribution pension scheme in terms of Rly. Board's letter No. F(E)/III/2003/PMI/24 dt:31.12.2003. (RBC 225/03).
- 6) He will be held responsible for the charges and care of Govt. goods and stores and other property that may be entrusted to him.
- 7) No change of category will be permitted unless he is not medically suitable for the present category and change of category will not be permitted before completion of 3 years of regular service in the cadre.
- 8) In all matters not specifically provided for herein in the recruitment rules, he will be governed by provisions of the Indian Rly. Establishment code and other extent orders as amended and issued from time to time.
- 9) He is not eligible for Inter Divl. Transfer before completion of 3 years of regular service from the date of his appointment against working post.
- 10) He should be prepared to serve anywhere in Madurai Division.

This office may be advised of the date on which the Apprentice joins at SSE/C&W/O/MDU and his movement may also be advised. He is directed to undergo necessary training at C&W Department as per the training programme in Annexure 'A'.
