

**The promotion of the above employee is subject to the following conditions:**

- 1 The above promotion will take effect only from the date of shouldering higher responsibilities.
- 2 There is no DAR/SPE/ Vigilance case pending / contemplated against him.
- 3 He is eligible to exercise an option for fixation of pay to the promoted grade within one month from the date of promotion in the prescribed proforma.
- 4 There is a probation period of 12 months in the promotional grade. At the end of probation period if the appointing authority considers that the work of the Railway servant during the one year probation period on promotion has not been satisfactory or the same is needed to be watched for some time, he may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of promotion as the case may be, as stipulated.
- 5 They will seek the further avenue of promotion as Bridge Operator-II with GP. Rs. 2400 in the normal course.

The date of shouldering higher responsibility should be advised to this office immediately.
