Their appointment is subject to the following conditions:

1. They should undergo the prescribed training and pass successfully. If they does not complete the same successfully, they are eligible for second chance without stipend if considered necessary by the Administration.
2. If they fail in the initial training and also in the repeat course they will be discharged from service.\
3. They will be on probation for a period of 02 years from the date of their regular absorption after successful completion of training and their confirmation shall be subject to their satisfactory of performance during the period of probation.

4. They will be responsible for the Government Money, Goods and stores and other property that may be entrusted to him care in the discharge of his official duties.
5. No change of category will be permitted for a minimum period of Three years unless they are not medically suitable for the category.
6. They are not eligible for Inter Divisional Transfer before completion of three years of regular service from the date of their absorption.
7. They should be prepared to serve anywhere in Madura division.
8. It must be clearly understood that his employment is temporary and that his services may be terminated at any time without notice if such termination is due to expiry of the officiating vacancy in which he is appointed or due to his removal or dismissal as a discipline measure after compliance with the provision of class (2) of Article 311 of the constitution of India.
9. The appointing authority however, reserves the right of terminating their services forthwith or before the expiry of the stipulated period noticed by making payment to them or the sum equivalent to pay & allowances for the period of notice or the unexpired portion thereof. They should not resign or quit their employment except with the previous consent in writing of the Head of the Department or Office in which they are employed.
10. In all matters not specifically provided for herein or in the recruitment Rules, he will be governed by provision of the Indian Railway Establishment codes and other extant orders as amended and issued from time to time.




